ACT NO. 4 OF 2020

Supplementary Appropriation (2012/2013) Act, 2020

An Act to make supplementary provision for the issue of the sums necessary to meet the supplementary public expenditure for certain purposes during the year ending on the 31st March, 2013 from the Consolidated Fund of the Government of Lesotho.

Enacted by the Parliament of Lesotho.

Short title and commencement

1. This Act may be cited as the Supplementary Appropriation (2012/2013) Act, 2020 and shall be deemed to have come into operation on the first day of April 2012.

Issue from the Consolidated Fund

2. There may be issued from the Consolidated Fund, the sum of M618,426,756 (Six Hundred and Eighteen Million, Four Hundred and twenty Six Thousand, Seven Hundred and Fifty Six Maloti) for the purposes specified in section 3.

Purposes to which the money is to be applied

3. The amount of moneys granted by this Act shall be applied for the purposes of meeting the aggregate supplementary expenditure approved for each head as set out in the Schedule.

The Parliament of Lesotho

Statement of Objects and Reasons of the Supplementary Appropriation (2012/2013) Act, 2020

(Circulated by authority of the Honourable Minister of Finance Dr. Moeketsi Majoro)

The object of this Bill is to make supplementary provision for the amount of M618,426,756 which was issued from the Consolidated Fund to cover supplementary expenditure under the Recurrent Budget and the Capital Budget for the fiscal year 2012/2013.

The sources of the amount to be appropriated are advances made from the Contingencies Fund amounting to M151,176,345 out of M100,000,000 appropriated in the 2012/2013 fiscal year and M131,459,579 out of M176,689,670 supplementary provisions made on the Contigencies Fund. The Supplementary Estimates for the Capital Expenditure constitute reallocation of approved Government funding among on-going projects amounting to M333,437,087.

The Bill is introduced in accordance with section 112 (3)(a) and (3)(b) and section 114(1) and 114(2) of the Constitution of Lesotho.

ACT NO. 5 OF 2020

Supplementary Approprition (2013/2014) Act, 2020

An Act to make supplementary provision for the issue of the sums necessary to meet the supplementary public expenditure for certain purposes during the year ending on the 31st March, 2014 from the Consolidated Fund of the Government of Lesotho.

ENACTED BY THE PARLIAMENT OF LESOTHO.

Short title and commencement

1. This Act may be cited as the Supplementary Appropriation (2013/2014) Act, 2020 and shall be deemed to have come into operation on the first day of April 2013.

Issue from the Consolidated Fund

2. There may be issued from the Consolidated Fund, the sum of M1,008,254,313 (One Billion and Eight Million, Two Hundred and Fifty Four Thousand, Three Hundred and Thirteen Maloti) for the purposes specified in section 3.

Purposes to which the money is to be applied

3. The moneys granted by this Act shall be applied for the purposes of meeting the aggregate supplementary expenditure approved for each head as set out in the Schedule.

Statement of Objects and Reasons of the Supplementary Appropriation (2013/2014) Act, 2020

(Circulated by authority of the Honourable Minister of Finance Dr. Moeketsi Majoro)

The object of this Bill is to make supplementary provision for the amount of M1,008,254,313 which was issued from the Consolidated Fund to cover supplementary expenditure under the Recurrent Budget and the Capital Budget for the fiscal year 2013/2014.

The sources of the amount to be appropriated are advances made from the Contingencies Fund amounting to M156,200,541 out of M100,000,000 which was appropriated for the 2013/2014 fiscal year and M60,000,000 replenished into the Contingencies Fund from the balances of various items in all ministries. The Supplementary Estimates for Capital Expenditure constitutes M547,408,884 from reallocation of approved Government funding among the on going projects and M304,644,888 from donor unappropriated disbursements.

The Bill is introduced in accordance with section 112 (3)(a) and (3)(b) and section 114(1) and 114(2) of the Constitution of Lesotho.

ACT NO. 6 OF 2020

Supplementary Approprition (2014/2015) Act, 2020

An Act to make supplementary provision for the issue of the sums necessary to meet the supplementary public expenditure for certain purposes during the year ending on the 31st March, 2015 from the Consolidated Fund of the Government of Lesotho.

ENACTED BY THE PARLIAMENT OF LESOTHO.

Short title and commencement

1. This Act may be cited as the Supplementary Appropriation (2014/2015) Act, 2020 and shall be deemed to have come into operation on the first day of April 2014.

Issue from the Consolidated Fund

2. There may be issued from the Consolidated Fund, the sum of M1,862,002,814 (One Billion Eight Hundred and Sixty-Two Million, Two Thousand, Eight Hundred and Fourteen Maloti) for the purposes specified in section 3.

Purposes to which the money is to be applied

3. The moneys granted by this Act shall be applied for the purposes of meeting the aggregate supplementary expenditure approved for each head as set out in the Schedule.

The Parliament of Lesotho

Statement of Objects and Reasons of the Supplementary Appropriation (2014/2015) Act, 2020

(Circulated by authority of the Honourable Minister of Finance Dr. Moeketsi Majoro)

The object of this Bill is to make supplementary provision for the amount of M1,862,002,814 which was issued from the Consolidated Fund to cover supplementary expenditure under the Recurrent Budget and the Capital Budget for the fiscal year 2014/2015.

The sources of the amount to be appropriated are advances from the Contingencies Fund amounting to M82,845,659; authorized funding of M200,000,000 for general elections held in February 2015 which were financed from the Government Bond account held with the Central Bank of Lesotho; and additional funding of M89,630,141 withdrawn from the Consolidated Fund, to finance the shortfall in the salary bill; additional funding of M164,488,919 of advances withdrawn from the Centralized Items, Head 30. M547,408,884 from reallocation of approved Government funding among the on going projects and M304,644,888 from donor unappropriated disbursements.

The Bill is introduced in accordance with section 112 (3)(a) and (3)(b) and section 114(1) and 114(2) of the Constitution of Lesotho.
