GENERAL PROCUREMENT NOTICE

The Government, acting through the Project Implementing Unit ("the Client"), intends to utilize Government of Lesotho (GoL) funds to eligible Service Providers who will be awarded contracts in fulfilment of Health facilities maintenance. Following the Act repealing and winding up of MCA-L Authority Act of 2008, which stated that LMDA would continue as Health Maintenance Project Implementing Unit (PIU) under Ministry of Finance and Development Planning, there is a need to continue with Health Facilities Maintenance.

The Period covered by this General Procurement Notice is April 2024 to March 2025. The requirements of the programme for April 2024 to March 2025 include Non-Consulting Services, Goods and Works as per Table 1 below:
